Please include the following documents with the Final Plat Application:
☐ Final Plat Application: Completed and signed Preliminary Plat Application.
☐ Final Plat: (4) full-size paper copies of the Preliminary Plat; digital copy (PDF) of the Plat emailed to the Principal
Planner at the time of application.
☐ Fees: The fee for a Final Plat Application includes:
 Application Fee: \$350 (due at time of Application)
☐ Public Improvements Contract Price: The City Engineer will review the Contract Price paid for improvements to determine the required bonding amount for the Maintenance Bond.
☐ Maintenance Bond: Letter of Credit (LOC) or otherwise accepted bond, in accordance with the requirements of the Final Plat Ordinance.
Final Plat Process:
☐ Application : A completed Application, including the Final Plat and Fee.
☐ Inspections : All improvements required by the approved Infrastructure Plans must be inspected, tested, and approved prior to filing of the Final Plat with City Council.
☐ Review : The Technical Review Team (TRT) will review the proposed Final Plat and provide the Applicant and their Design Professional with Review Comments; the TRT will review subsequent Submittals for final review of all requirements of the Final Plat Plat Ordinance prior to scheduling the Final Plat for consideration of City Council
☐ Staff Report: The Technical Review Team (TRT) will prepare a Staff Report to be presented to P&Z/City Council.
☐ City Council, First Reading : City Council will hold a Hearing on the request; Staff will present a Staff Report for Council's consideration.
☐ City Council, Second Reading: City Council will render a decision on the request.
