Please include the following documents with the **Preliminary Plat Application:**

- Completed Guarantee of Payment Agreement.**
- Preliminary Plat Application:** Completed and signed Preliminary Plat Application.
- Preliminary Plat:** (2) full-size paper copies of the Preliminary Plat; digital copy (PDF) of the Plat emailed to the Planner at the time of application.
- Deed.** Copy of current Deed indicating property ownership.
- Traffic Impact Study (TIS):** A digital copy of the TIS, in accordance with parameters identified by the TRT
- Fees:** The fee for a **Preliminary Plat Application** includes:
  - **Application Fee:** \$500 + \$2/Lot (due at time of Application)

### **Minor Subdivision Process:**

- Pre-Application Meeting:** A Pre-Application Meeting with the Technical Review Team (TRT) is required.
- Application:** A completed Application, including the Deed, Survey(s), and Fee.
- Review:** The Technical Review Team (TRT) will review the proposed Preliminary Plat and provide the Applicant and their Design Professional with Review Comments; the TRT will review subsequent Submittals for final review of all requirements of the Preliminary Plat Ordinance prior to scheduling the Preliminary Plat for consideration of the Planning & Zoning Commission.
- Staff Report:** The Technical Review Team (TRT) will prepare a Staff Report to be presented to P&Z/City Council.
- Hearing, Planning & Zoning Commission:** The Planning & Zoning Commission will hold a Hearing on the request; Staff will present a Staff Report. The Planning & Zoning Commission will make a recommendation for or against the Preliminary Plat Application to City Council.
- Resolution, City Council Meeting:** Staff will present the Staff Report and the Planning & Zoning Commission's Recommendation to City Council; City Council will render a decision on the request.
